Annual Meeting Minutes

December 8, 2020

President Chris Zoller called the meeting to order at 9:00 AM. Emily Marrison led the Pledge of Allegiance and provided a thought for the day which included reflection on her word of the year for 2020: "pace".

Sabrina Schirtzinger, Chair of Membership Recruitment and Retention announced a total of 377 members for 2021. Due to the late membership drive she did not have a list of new members to share. Debby Lewis shared the names of new members later in the meeting after the committee reports.

Secretary Report – Jenny Lobb asked attendees to review the 2019 Annual Meeting minutes as printed in the annual report. Gigi Neal motioned to approve the minutes. Amanda Raines seconded the motion. Motion passed.

Treasurer Report – Melinda Ryan reviewed the report printed in the annual report. There was a net gain of \$21,282.78 in FY2020 as the total JCEP income was \$31,003.51 and total expenses were \$9,720.73. The checking account balance was \$141,876.75 and total available JCEP funds are \$187,414.42.

Kyle White motioned to accept the treasurer's report. Adam Ziadeh seconded the motion. Motion passed.

Annalist Report – Michelle Treber led the remembrance to honor current and former Extension employees who passed away in 2020. Remembered were Darrel Acker, Alice Moore, Garry Gibbons, Melvin (Mel) Krill, Roberta "Bobbi" (Dickerson) Hughes, and Walter H. Schmidt.

ESP President Report – Eric Barrett talked about the benefits of ESP membership and highlighted the professional development grant awarded to OSU Extension in 2020 for the mentoring program. Eric introduced Steve Brady as the 2021 ESP President and together they welcomed new members. Eric read the names of new members and the ESP creed, which is available on the ESP website.

CES/TERSSA Report – Adam Ziadeh welcomed Carol Wagner as the 2021 president and Patti Corfman as the president-elect. Christina Byrd from Franklin County is the national president and plans are underway for Ohio to host the national conference in 2022.

National Association President Reports

Full reports are included in the 2020 Annual Report. Each president stated the following highlights for their report.

NACAA – Gigi Neal – no summer retreat due to COVID-19 restrictions. Annual conference was held virtually September 28 – October 1. The 2021 president is Marcus McCartney and the president-elect is Amanda Bennett.

NACDEP –Kyle White – monthly Community Development meetings were held virtually through 2020. Kyle invited all members to attend and learn from their CD colleagues. The 2021 president is Gwynn Stewart and the president-elect is Brooke Beam.

NAE4-HYDP – Amanda Raines - annual conference was held virtually October 20-22 and included 25 presentations from Ohio 4-H professionals. A hybrid conference is planned for November 2021. The 2021 president is Kelly Coble and the president-elect is Christy Clary.

NEAFCS – Jami Dellifield – annual conference was held virtually September 14-16. Ohio received six national awards and seven regional awards. Two Ohio members were elected to the national board: Kate Shumaker is serving as secretary and Pat Brinkman is vice president of professional development. The 2021 president is Cheryl Barber-Spires and the president-elect is Tammy Jones.

ANROP – Ed Brown – there are 31 members for 2021. The 2021 president is Ashley Kulhanek and the president elect is Sabrina Schirtzinger.

NAEPSPD – Amanda Rysz – In 2020 the organization had 21 members from OSU and two from CSU. Three Ohio members served on the national board in 2020: Danae Wolfe was the North Central region representative, and Amanda Rysz and Teresa McCoy co-chaired the awards committee. The 2021 president is Jared Morrison.

OSU Extension Retirees & Life Members Report – Ron Overmyer and Gary Wilson – the annual retiree's luncheon that was scheduled for September 14, 2020 was canceled. The 2021 luncheon is scheduled for September 13 at the Beck's facilities in London, Ohio.

Committee Reports

Full reports for all committees are included in the 2020 Annual Report. Each committee chair stated the following highlights for their report.

Global Relations Committee – Elizabeth Varanese – two trips planned for 2020 were canceled. The focus for 2020 was on cultivating partnerships.

Marketing Committee – Shannon Carter - In 2020 the committee continued to develop the JCEP Facebook page and following as a platform for both recruitment and communication.

Membership, Recruitment and Retention Committee – Sabrina Schirtzinger – no mid-year membership drive due to the spending freeze. The 2021 membership drive garnered 377 full members and 55 affiliate members.

Personnel Committee – Allen Gahler – the committee met three times in 2020 and had good discussions with Greg Davis and Jeff McCutheon regarding their four established priority areas: evaluation metrics for area leaders, the salary review process and the effects of the new minimum wage, changes to promotion and tenure process, and evaluation of the current system for filling vacant positions.

Policy Ad-Hoc Committee – Pam Montgomery – the policy committee was a new committee established in 2020 to review the constitution and the bylaws. The board voted on and approved changes (mainly grammatical) to the bylaws on October 12. Constitution changes (also mainly grammatical, as well as the addition of a non-discrimination statement) were sent to membership on November 23 for review prior to a vote later in the meeting.

Professional Development Committee – Tom deHaas – 2020 priorities included the on-boarding program led by Amanda Rysz and the LOD unit, the mentoring program in development with the LOD unit after receiving an ESP grant, and proposal review for the annual conference.

Public Issues Committee – Doug Foxx – the committee met early in the year to prepare PILD conference attendees to meet with elected officials while attending the conference. The committee also met with Adam Ward and Jackie Wilkins later in the year to discuss when or if it is appropriate for an Extension professional to take a position on an issue. The committee will be working with Adam's office and the LOD unit in 2021 to create training for Extension professionals on how to work with elected officials.

Resource Development and Management Committee – Nate Arnett – with expenses down during FY2020, JCEP was able to offer savings on membership dues for 2021. Audit completed, preparing for transition to Workday.

Sharon S. Dearth, passed away on December 6, 2020. Before retiring as secretary, after 30 plus years of service, Sharon was known as the face of the Washington County Extension office. She was a dear friend to many.

Carolyn Rose Whittington, died on December 22, 2020. Carolyn was a SNAP Ed Program Assistant for 18 years working in Clinton, Fayette, and Pickaway Counties. She was an advocate for the ALS community and participated in research, funding and education related to this disease. Carolyn's daughter, Carrie Whittington-Hogue works for OSU Extension in Pickaway County.

John M. Smith Sr. passed peacefully on January 13, 2021, at the age of 92. He was the Agriculture Extension Agent for 30 years before retiring at 85 years young. After retirement from OSU, one would rarely see John in anything other than his Scarlet and Gray attire and driving his red SUV with "MSU2OSU" license plate and OSU decals on the doors.

Betty Jean Richter Reese, age 80, of Athens, died Friday Feb. 5, 2021. She received her bachelor's degree from Wichita State University and her master's degree from Michigan State University. She was employed at the cooperative extension service with The Ohio State University. She was a volunteer at The Dairy Barn Arts Center and the Ohio University Kennedy Museum of Art.

Robert Duane Plymale, age 77, of Jackson, Ohio, passed away unexpectedly Wednesday, March 3, 2021, at home on his family farm. Duane worked for 35 years as a 4-H Youth Extension Specialist for the Ohio State University. He mentored thousands of children, youth, and adult volunteers over his decades of employment. His influence on youth leadership and the 4-H program in Ohio cannot be quantified. Duane was an avid hunter and fisherman and college sports enthusiast. He loved cheering for his favorite teams, BYU and Ohio State! Duane loved developing and improving his Angus cattle and worked tirelessly to establish a top-notch and nationally respected, Angus herd. He loved helping both new and established farmers to grow their own herds, and many of the genetic lines he cultivated are prevalent in herds around the country.

George Sherer passed away Friday, March 19, 2021. He graduated from Green Springs High School, and Ohio State University with B. S. and M. S. degrees. He was first employed by the Ohio Farm Bureau and then the Ohio State Cooperative Extension Service in Perry and Morgan Counties, where he retired after 25 years of service. 2. Summary of GRC Minutes Outcomes

The Committee met 4 times (February 1st, 2021; March 22nd, 2021, June 7th, 2021; and October 12th, 2021) and several subcommittee levels meeting this year to discuss important opportunities and issues for extension professionals, staff and faulty.

a. Opportunities and Issues discussed include the following

i. Formation a Domestic Multicultural Engagement Initiative

The goal of this initiative is to strengthen OSU and Central State Extensions engagement with domestic multicultural groups in the State of Ohio. It will be a great opportunity to learn more about cultural and ethnic groups in Ohio and assist them in their annual festival

planning needs and programs. It was suggested we begin by creating a database of all multicultural groups in Franklin County and expand to other counties.

ii. Farmer -to- Farmer Projects and Funding

This year we explored the opportunity to access funds through the USAID-funded John Ogonowski and Doug Bereuter Farmer-to-Farmer (F2F) Agricultural Volunteer Opportunity Project (AVOP) Program so that staff and educators could travel abroad to volunteer. We identified and had an initial conversation with agricultural experts of Botswana University of Agriculture and Natural Resources to collaborate on the project. We concluded that widespread water shortages posed a significant threat to the agriculture sector in Botswana. The application even though was drafted and completed; we didn't submit it. This effort was led by Chris Igodan and Godwin Apaliyah. We plan to try again next year. At least and to the best of my knowledge two Farmer-to-Farmer remote projects were completed by an OSU Extension staff - Godwin T. Apaliyah. The topic was "Organizational Leadership and Management Training" for cooperative farmer groups in two separate communities – Mwanza and Mbuso (Mbeya) in Tanzania. The non-for-profit organization responsible for this training was International Executive Service Corps (IESC).

iii. OSU Extension Farm Science Review

GRC participated in this year's, 2021 Farm Science Review Event. Only a handful of members volunteered this year, but overall, the event was successful - A few volunteers signed up. People who visited the booth were asked to take a quiz to test their knowledge about international food, geography, and population. Approximately 330+ visited the booth. We concluded that it was worth the effort be there and worth doing again next year. We will discuss improvements for next year and will submit a budget for the event. OJCEP donated \$150.00 to GRC for the event. We only used \$25 to purchase pencils and squeeze balls for prizes. The prize wheel activity was very interactive. Overall, a very engaging activity and effort which was led by Jacqueline Kowalski and Elizabeth Varanese

iv. Pilot International Experience – OSU Extension engagement with the global community

Plans were made to make trips to Honduras and Greece. The trips were not made because of the Cod 19 pandemic. We will re-examine the possibilities of making these and other trips next year and when the pandemic gets under control globally. We also planned to explore the use of companies that coordinate agricultural tours – e.g., Explorations by Thor, a company that coordinates agricultural tours/experiences globally

v. Globalizing Extension Innovation Network (GEIN)

This year we explored the opportunity of becoming a member of GEIN. This open group creates a network of professionals interested in globalizing Extension innovation. It shares and develops best practices for augmenting extension programs through cross-cultural and international experiences. The network supports the engagement of extension professionals through educational programs emphasizing understanding of global dynamics and using cultural knowledge.

vi. Office of international Affairs - Fulbright Program

A guest speaker from Office of International Affairs - Joanna Kukielka-Blaser, Director, Fulbright Scholar and Fulbright-Hays Programs presented an overview of scholarship opportunities for faculty and staff at the University.

The Outreach Lecturing Fund (OLF) https://www.cies.org/program/outreach-lecturing-fund provides funding for campuses to host Fulbright Visiting Scholars, already in the United States, for short-term speaking engagements. Carnegie African Diaspora Fellowship Program https://www.iie.org/programs/carnegie-african-diaspora-fellowship-program. This is a

fellowship program for educational projects at African higher education institutions. This

program is open only to African-born scholars, but it still may be applicable to some of our staff/faculty members.

vii. Other Activities Suggested are as follows

- Make a map and ask extension professionals who have visited abroad for volunteer work to show where they have travelled to and share their experiences.
 This could be an event that could take place during a JCEP meeting in Columbus.
- Collaborate with OSU Alumni and OSU Extension Alumni to explore potential connection and support for global experiences.

The Personnel committee met 6 times in 2021, and established 3 priority areas to work on, including investigation of the salary review process and the effects of the \$15/hr minimum wage changes; analyzing the structure of the annual conference in conjunction with the professional development committee; and understanding/evaluation the organization hierarchy of OSU Extension with a specific focus on the area leader structure.

Members of extension administration were invited to two of the meetings to discuss these priority points, with Greg Davis joining us for discussion on salary review, merit increases, and career road mapping. The committee learned that \$15/hr. raises have caused significant compression and that the University senate is studying similar institutions within the North Central Region. Reviews have only been faculty level, however, so work for this committee may exist at lower levels, but all equity reviews at OSU are on hold in 2021. The committee was advised that salary variation will always exist and is not set up with an averaging component, just performance-based rewards. The committee advised the JCEP board to recommend to Extension administration that merit increases be based on real dollars from within the allocated pool, not a percentage basis.

Jeff McCutcheon led a discussion and q/a session on the area leadership structure, sharing results of survey data from Extension faculty and staff. It was indicated to the committee that no formal evaluation tools had yet been developed for the area leader structure, but administration was working on it. The area leader selection process was also discussed, and it was described as an application and interview process, but in the occurrence of vacancies, recruitment by administration within geographic area was being utilized.

Another point of discussion with administration from this committee centered on peer review letters from area leaders and state specialists, with rank of those people often being an issue. The committee recommended to the board that administration should be advised to accept peer letters from area leaders regardless of rank, with the acknowledgement that those looking to achieve faculty status would not have a letter from a non-faculty area leader count in their promotion process.

The committee also worked to organize a session at Extension annual conference on retirement planning, and someone from HR will participate in a question/answer session for this. Finally, the committee selected Chris Zoller to be the chair for 2022, with Sandy Smith as vice chair, and identified key topics for 2022, including:

- Salary review and comparisons with other universities. Faculty only study completed in 2014
- Ongoing review of area leader concept and evaluation/impact
- What is the status of the college's roadmap?
- What has been the impact of the \$15/hr. wage

Chair Doug Foxx provided an overview of the committee's purpose and welcomed new and returning members. Everyone introduced themselves and everyone was particularly excited to meet our Central State Colleagues that have joined the committee.

Foxx shared an update from a phone conversation with CFAES Director of Government Relations Adam Ward in which Ward had reported the Governor's Blue Book (first draft of the state budget) was to be released later that day. Ward and Dean Kress will analyze the budget and report impacts on Extension and OARDC line items soon.

The committee had discussion about the unique role of Adam Ward and our CFAES Government Relations Office and how that fits in with the University level Government Relations team and learned about the Government Relations reporting structure at Central State University. Former State Senator Chris Widener is the main CSU Government Relations contact.

Foxx reported that Kristy Watters, Jo Williams, and himself had presented a breakout session during Extension Annual Conference on Elevator Speeches and Key Messages. However, per our Fall meeting with Adam Ward and OSU Extension Director Jackie Wilkins – our committee is currently tasked with coming up with a more detailed Government Relations training for all Extension employees.

The committee began discussion over how to put this training together and quickly came to agreement that a detailed training should be targeted at Government Relations / Legislative Stewards and not all Extension employees. Emily Marrison reported that efforts were

underway for revising the on-boarding process and that perhaps a short high-level session on telling Extension's story / communicating with stakeholders would be appropriate for all new employees. After more discussion the committee strongly felt we need more clarification from Jackie and Adam about exactly what the role of OSU Extension Legislative Stewards is / should be and that we should not create a training until we know exactly what that role and subsequent assignments would be for legislative stewards to complete. There was strong consensus that the Legislative Stewards are eager to do something but thus far have not been effectively utilized under the new stewardship model.

Additionally, several members of the committee expressed strong interest in receiving more regular updates on bills that are of interest and/or being monitored by Extension and CFAES. Committee members are interested in receiving some type of regular e-mail update including the status of bills such as twice a month or monthly and are interested in having more regular updates from the Government Relations staff.

There was also much discussion over what should the role of our Extension clientele / volunteers be in communicating with and advocating for Extension with public officials. The committee feels that a separate detailed training should be created for volunteers – but again only if there are specific roles or assignments that we can empower these individuals to fulfill.

Many committee members expressed interest in being a part of future legislative luncheons / legislative visit days. There also was discussion about this year's PILD Conference being virtual and agreement that Ohio should be represented. However, it was also mentioned that since this event will be virtual it does not seem likely that any meaningful dialogue or communication will occur between our PILD Delegates and members of Ohio's Congressional delegation or their staff.

The committee identified the following specific questions for Extension Administration and/or Adam Ward:

- Help us identify roles and expectations
- What are our roles?
- What are we allowed to do and not allowed to do?
- How do we involve / engage Extension Advisory Committees and other key volunteers / clientele in advocacy at the local, state, and federal levels?

Doug Foxx and Chris Bruynis will follow up with Jackie Wilkins and Adam Ward and report back at the next meeting.

The Ohio JCEP Public Issues Committee met via ZOOM today from 11 am – 12 noon. Chair Doug Foxx called the meeting to order and welcomed everyone. Foxx introduced CFAES Director of Government Affairs Adam Ward. Ward presented an update on the state and federal budget processes and explained that at the state level OSU Extension experienced

only a 5% cut in our state appropriation. He is now working on getting us back to flat funding based on our original 2021 budget allocation of about \$25 million.

Ward welcomed our colleagues from Central State University and reported that he is working with administration on a new memorandum of understanding between OSU Extension and Central State Extension.

Ward shared in follow up to a meeting Foxx and Chris Bruynis had with him this past Friday several updates. Ward plans to start up regular ZOOM Updates again soon, which were not held throughout this past year due to all of the things he was managing related to COVID. Ward now has Ellen Essman on his team who will help to coordinate these ZOOM updates along with developing a basic training for all employees and new employees that come through on-boarding and then a more intermediate level training on Government Affairs, advocacy, and working with elected officials for the Legislative Stewards. Ward is also going to work on clarifying the role and duties of the Legislative Stewards.

Ward would like to build up more of our Council on Agriculture Research and Teaching (CARET) Delegates. We currently have three who would continue to represent us at meetings in Washington DC, but Ward would like to add more of these key leaders that have strong relationships with elected officials.

Ward is looking to involve the legislative stewards in helping with the upcoming August Congressional Staff Tour. He is looking to getting back to engaging with legislators and legislative staff in-person this summer.

Foxx asked Dr. Lyda Garcia and Ward to speak about how things were going in terms of the heavy demand placed on our custom livestock processors. Ward and Garcia reported that they have been working together and Ward shared that Ohio Department of Agriculture (ODA) Director Dorothy Pelanda shared that the partnership between Ohio State and ODA is their greatest partnership.

It was reported that we have at least two PILD delegates that will be representing Ohio JCEP at the PILD Conference. It was also discussed that we are to have some diversity, equity, and inclusion representatives included in the legislative stewards that are able to respond quickly and speak in an informed manner on these topics when issues arise related to these topics and Extension programming.

Foxx shared that during their meeting this past Friday with Dr. Wilkins she explained some of the history of the JCEP Public Issues Committee and that one of the aspects that has been challenging for the Public Issues Committee and some other JCEP committees is the constant turn-over from year-to-year of leadership and committee members and wondered if we might look at possibly having people serve two year terms in the future that might be renewable for a 2nd two year term to provide some more stability and leadership to enable projects to move from discussion to completion before new leadership takes over. Our committee discussed this and seemed to be supportive of this.

As we wrapped up our conversation – Foxx summarized that our goal in working with Ellen Essman in Adam's office is to get the ZOOM updates established again soon and on a regular schedule and to get the training developed and roles clarified for the Legislative Stewards.

Our committee met and heard an update from Ellen Essman with CFAES Government Affairs. Since our last meeting the Government Affairs team has re-established the monthly Government Affairs Video Updates for Legislative Stewards and JCEP Public Issues Committee members. We asked Ellen about if any progress had been made on developing the Government Affairs training module for new Extension employees and one for existing Extension employees. The training modules have not been created as Adam Ward – CFAES Director of Government Affairs – indicated he did not want to get out ahead of Jackie Wilkins – OSU Extension Director on creating these materials.

Several members of the public issues committee expressed frustration that these modules have not been created as it was our understanding from meetings earlier in the year that Adam and Jackie had discussed what should be included in these modules and directed Ellen to take the lead on developing them. Outstanding Regional Collaboration Achievement Award was awarded to Eugene Braig, OSU Program Director of Aquatic Ecosystems in the School of Environment and Natural Resources, and team for their "North Central Region Algal Bloom Action Team Regional Research Symposium".

Synopsis: The North Central Region (NCR) Algal Bloom Action Team was formed in 2018 to review Extension programs in the NCR related to harmful algal blooms (HABs) and recommended future HAB outreach. The team is comprised of representatives from Extension and Water Resources Research Institutes at each of the Land-Grant universities within the NCR. After performing a region-wide needs assessment and publishing a report on its findings, the team has been working to make emergent HAB research accessible to agriculture and natural resource educators across the region. The group is working to create HAB webinars, fact sheets, a comprehensive frequently-asked-questions database, and a photo library of HAB images. As part of their work, the team hosted a Virtual Harmful Algal Bloom Research Symposium in January 2021 where more than 890 educators and researchers from across the USA heard the latest HAB research and discussed ongoing outreach efforts.

Ohio Joint Council of Extension Professionals Constitution

ARTICLE I - NAME

The name of the organization shall be the Ohio Joint Council of Extension Professionals (OJCEP). OJCEP shall be the Alpha Eta chapter of Epsilon Sigma Phi (ESP).

ARTICLE II - PURPOSE

The mission of the organization shall be to promote professional development and supportprofessionals within Extension in Ohio.

ARTICLE III - MEMBERSHIP

Section 1: Membership shall be Annual or Life member.

- A. Annual membership: Any Ohio Extension employee who is current with their dues may be an annual member of this association.

Section 2: Executive, Board and Special Meetings of the organization shall be held asspecified in the By-Laws.

ARTICLE VI - AMENDMENTS

Section 1: The Constitution shall be amended, revised or repealed by two-thirds vote of the members of the organization participating in the membership meeting (electronic voting and teleconference meetings allowed).

Section 2: The amendments or revisions of the Constitution shall take effect as soon as adopted.

Section 3: The Constitution may be amended provided written notice stating the substance of the proposed amendments has been sent to each member at least fifteen (15)days in advance of the membership meeting.

Ohio Joint Council of Extension Professionals By-Laws

ARTICLE I - NAME AND PRINCIPAL OFFICE

Section 1: The name of the organization shall be the Ohio Joint Council of Extension Professionals (OJCEP).

Section 2: The principal office of the organization will be housed at the office of the current organization Treasurer.

ARTICLE II - MEMBERSHIP

- Section 1: Membership in the organization shall be from January 1 to December 31.
- Section 2: The membership dues deadline is October 31 and the dues are for the period January 1 to December 31 of the following year.
- Section 3: Change in rate of annual dues must be approved by the majority of the Board.
- Section 4: Annual membership has two levels with benefits and limitations as described below:
 - Full member Full access to Ohio JCEP offices and benefits.
 - Affiliate member Limited to support staff only, access to affiliate-only Ohio JCEP scholarships/professional development support, may hold Ohio JCEP office to represent CES only, restricted awards eligibility, may fully participate in Ohio JCEP committees but not hold Chair/Chair- elect roles.
- Section 5: To be eligible for awards or to run for elected office (as consistent with membership level), members must have paid their membership dues by October 31 for the current membership year.
- Section 6: Those newly employed will be exempt from the previous year membership requirement.
- Section 7: Members must complete their membership form on-line and submit it electronically to the organization Treasurer.

ARTICLE III - BOARD OF DIRECTORS

Section 1: Board of Directors shall consist of:

- Past President
- Annalist
- Secretary
- Treasurer
- State Association President: Eight (8):

 President, Epsilon Sigma Phi (ESP) State President, National Association of County

 Association of Extension 4-H Youth Development Professionals (NAE4-HYDP)
 State President, National Extension Association for Family and Consumer Sciences
 (NEAFCS) State President National Association of Extension Program & Staff
 Development Professionals (NAEPSPD), State President Chi Epsilon Sigma/The
 Extension and Research Support Staff Association (CES or TERSSA)
- State Association President-Elects: Eight (8): Refer to organizations listed above
- Committee Chair: Nine (9)
 (Global Relations; Marketing; Membership Recruitment and Retention; Personnel; Professional Development; Public Issues; Resource Development and

Management; Scholarships, Grants and Recognition, and Policy)

- Retiree/Life Member
- Section 2: Terms on the Board of Directors shall be as follows:
 - A. The President-Elect is elected annually. President-Elect is a three-year commitment and shall become President the year following the President- Elect term and become Immediate Past-President following the term as President.
 - B. The Secretary and Treasurer are two-year terms and shall serve no more than two consecutive terms. The Secretary and Treasurer terms will be elected on alternate years.
 - C. The Treasurer-Elect shall be elected the last year of the current Treasurer's term and serve no more than one year. In the event the current Treasurer does not fulfill their term, the Treasurer-Elect will assume the position of Treasurer.
 - D. The Annalist shall be elected to a two-year term and serve no more than two consecutive terms.
 - E. State Association President-Elect is a two-year commitment. State Association President-Elect officers are elected annually and shall become the State Association President the following year.
 - F. Committee Chairs will be selected by membership of the committee and are voting members of the Board. There is a limit of two 1-year terms in a Committee Chair position.
 - G. Retiree/Life Member Representative –one-year term from active life members appointed to Board.
- Section 3: A member shall hold only one Board voting position at any one time.
- Section 4: Vacancies shall be filled in the following manner:
 - A. Any position-elect shall assume the related position if those offices become vacant during the year. The Board shall appoint an appropriate representative to fill the remainder of the vacant position of any elected officer.
 - B. In the case of non-elected positions, the Board will seek nominations from that organization or committee to fill the term of the vacant position.

ARTICLE IV - MEETINGS

- Section 1: Annual meetings shall be held as determined by the Board of Directors.
- Section 2: Regular meetings shall be called as deemed necessary by the President and/or the Board of Directors.
- Section 3: Special meetings shall be called as deemed necessary by the President and/or five (5) members of the Board of Directors.
- Section 4: Quorum of the Board of Directors shall consist of half the membership plus one.
- Section 5: Parliamentary Procedure shall (except as herein provided) be conducted according to Roberts Rules of Order, Modern Edition.
- Section 6: Each Board member shall have one vote and the President shall cast the deciding vote

in the case of a tie.

Section 7: Members of the Board of Directors may be dismissed for missing two consecutive meetings unless excused.

ARTICLE V - BOARD OF DIRECTOR DUTIES

- Section 1: The election of Board members shall be held annually as determined by the Executive Committee. The term of office shall coincide with the membership year as stated in Article II, Section 1 of the By-Laws.
- Section 2: The President shall perform such duties as pertain to this office: prepare agendas and preside at the annual meeting and all Board meetings, represent, or appoint other members to represent OJCEP on committees or functions and keep lines of communication open among the OJCEP Board, national ESP, and the administration of Ohio land grant universities.
- Section 3: The President-Elect shall make all arrangements for the annual meeting, assemble, and distribute the OJCEP annual reports to members, channel suggestions from members to the attention of the officers and Board, preside over meetings in absence of the President.
- Section 4: The Past President shall work closely with the President, serve as chair of the Nominating committee, and conduct elections as determined the Executive Committee.
- Section 5: The Secretary shall keep full and accurate records of proceedings and attendance of all meetings of the OJCEP, receive and keep properly filed communications and attend to correspondence as directed by the President, and prepare official stationery.
- Section 6: The Treasurer shall keep a full and accurate record of all receipts and disbursements of OJCEP. The Treasurer shall pay bills and accounts for OJCEP as directed by the President and Executive Committee, OJCEP Board or by resolution passed by the membership. The Treasurer shall prepare financial statements for meetings, collect all membership dues, make deposits on a regular basis, record national association affiliation, provide appropriate information to the Membership Chair, work with State Association Presidents in submitting the dues for each National Association and give leadership to the Resource Development Management Committee.
- Section 7: Treasurer-Elect will be a non-voting Board member. This officer will serve as an apprentice to the current Treasurer for one year but, will not have check signing authority.
- Section 8: Annalist-Maintain the historical records of OJCEP and the ESP Alpha Eta Chapter.
- Section 9: State Association Presidents shall be a liaison and contact person with respective national associations and persons in other states with similar positions; represent OJCEP members who are members of respective national associations at annual and regional meetings of the respective national associations; appoint delegates and provide leadership for the Ohio delegation to national and other committees as necessary; coordinate and relay information concerning selection of respective national association award recipients to Scholarships, Grants and Recognition Committee; coordinate membership efforts with directors concerning membership in OJCEP and respective national associations; take responsibility for disseminating information concerning registration, travel arrangements, national elections, special meetings and other details of respective national association annual meetings; strive to promote fellowship among members at regional and state workshops and conference, etc.; keep the Board

informed and involved concerning decision, plans, and activities related to this position. The Association President will be encouraged to attend the Extension Leadership Conference with OJCEP covering expenses as determined by the Board of Directors.

- Section 10: The Association President-Elects shall assist the Association Presidents as requested and record proceedings of sectional meetings. The Association President-Elect will be encouraged to attend the Public Issues Leadership Development (PILD) Conference with OJCEP covering expenses as determined by the Board of Directors.
- Section 11: The Retiree/Life Member shall function as the liaison with Extension retirees and encourage life membership with recent retirees. Work with the Treasurer to update the national ESP life membership list.

ARTICLE VI - COMMITTEES

- Section 1: Standing committees shall be determined by the Board of Directors.
- Section 2: Committee Chair and Vice-Chair will be selected by the members of the committee present when vote is taken, no later than October 31 before their term commences.
- Section 3: Executive Committee: The executive committee shall be comprised of the Five (5) officers and the State Association Presidents. The purpose of this committee shall be to compose an agenda for all Board of Director meetings and determine election procedures for Board of Directors of the organization.
- Section 4: Personnel Committee: This committee shall monitor and report on salary and benefits information; monitor and access the advantages and disadvantages of the faculty promotion and tenure process or the advancement system of unclassified administrative and professional (A&P) and/or senior administrative and professional employees and conduct or obtain access to a salary analysis comparing North Central Regional States for faculty and non-faculty. Members of Extension administration are not permitted to serve on this committee.
- Section 5: <u>Global Relations Committee</u>: This committee promotes international opportunities and international programming within Extension. Liaison and connect with national ESP committee efforts.
- Section 6: <u>Marketing Committee</u>: This committee publishes communications used by members; oversees web development as well as additional technology-based member communications; works closely and clarifies roles with Membership Recruitment and Retention Committee. Liaison and connect with national ESP committee efforts.
- Section 7: Membership Recruitment and Retention Committee: This committee recruits, retains and involves all eligible Ohio Extension personnel; promotes an effective working relationship and spirit of fraternal fellowship among members. Initiates and coordinates annual membership process. Liaison and connect with national ESP committee efforts.
- Section 8: <u>Professional Development Committee</u>: This committee shall support, promote, and develop professional opportunities for Extension employees. Liaison and connect with national ESP committee efforts.
- Section 9: Public Issues Committee: This committee builds and strengthens political and public support for Extension through consistent and targeted communication with local, state, and federal decision makers and agencies; and educates and informs members about public issues and legislative matters affecting Extension programs and staff. Liaison and connect with national ESP committee efforts.

- Section 10: Resource Development and Management Committee: This committee generates new ideas for resource development and management for professional development activities; reviews and monitors the professional association's financial management plan. Liaison and connect with national ESP committee efforts.
- Section 11: <u>Scholarships, Grants and Recognition Committee</u>: This committee administers and provides leadership to the state, regional and national award programs and oversees the selection and distribution of professional development scholarships. Liaison and connect with national ESP committee efforts.
- Section 12: <u>Policy Committee</u>: This committee has the goal of ensuring the Board has policies and procedures in place to guide the operation of the Organization and adheres to these policies.
- Section 13: Ad Hoc Committee: An Ad Hoc Committee may be appointed by the President. No Ad Hoc Committee shall serve longer than twelve months unless re-appointed.

ARTICLE VII – FISCAL MATTERS

- Section 1: The OJCEP fiscal year is October 1 to September 30.
- Section 2: The funds of OJCEP shall be deposited in institutions as determined by the Board of Directors Executive Committee. The authorized signatories include the OJCEP Treasurer and the Past OJCEP Treasurer or OJCEP member recommended by the Treasurer and approved by OJCEP Board.
- Section 3: There shall be an annual audit of the financial affairs of OJCEP as determined by the Board of Directors Executive Committee. A report of the general financial condition shall be made annually to all members.
- Section 4: State Association Presidents shall provide approval and direction to the OJCEP

 Treasurer and Membership Chair as well as provide a contact address and deadline for national dues for fiscal matters specific to their respective state association.

ARTICLE VIII - AMENDMENTS

- Section 1: The By-Laws may be amended at any regular or special meeting (including electronic meeting/voting) of the Board of Directors by a majority vote of the Board members, provided that written notice stating the substance of the proposed amendment has been sent to each Board member at least ten (10) days in advance of the vote.
- Section 2: The amendments or revisions of the By-Laws shall take effect as soon as adopted.
