## Ohio Joint Council of Extension Professionals Annual Meeting Minutes December 5, 2022

**President Gigi Neal** called the meeting to order at 4:00 PM and led the Pledge of Allegiance. Thought for the day – a video of *Please Stay* by Jake Runestad conducted by Ethan Neal, Gigi's son, a senior at the University of Kentucky.

**Mark Badertscher,** chair of the Membership Recruitment and Retention Committee, announced 99 new members for 2023. Their names were displayed on PowerPoint slides and new members in attendance were asked to stand.

**Secretary Report** – Jenny Lobb asked attendees to review the 2021 annual meeting minutes as printed on pages 7-9 in the annual report. Amanda Raines motioned to approve the minutes. Shannon Carter seconded the motion. Motion passed.

**Treasurer Report** – Melinda Ryan reviewed the report printed on page 10 of the annual report, which is current as of September 30, 2022. Note: there is a transfer of \$63,893.33 that was taken out of the account by mistake. Central processing is correcting this error, and it will show in FY23, which will bring the total available JCEP funds to \$195,956.83. The report will be filed for audit.

**Annalist Report** – Erin Dailey explained the role of the annalist and led a remembrance to honor Extension employees who passed away in 2022. Remembered were Margaret Beckwith, Gary Bauer, Sheila Blevins, Carolyn Belczyk, Dona Hales, Jeff Layman, Duane Rigsby, Julie Strawser and Laura Butts Keesor.

ESP Report – Shannon Carter shared that Ohio had 336 members in 2022, which is more than any other state in the country. Ohio member Travis West is serving as president-elect of the National ESP Board of Directors. He will serve as president in 2024. Ohio had nine members attend the national conference in Branson, Missouri from September 26-29. Ohio member Teresa McCoy from the OSU Extension Learning and Organizational Development unit was formally recognized at the conference with the Diversity Multicultural team award for the Northeast Region. The 2023 national conference will be September 24-28 in Billings, Montana. Shannon read the names of 70 new (and some reinstated) ESP members and asked those in attendance to come to the stage to be inducted. Each new member received a copy of the Extension Workers creed.

## National Association President Reports

Full reports for all associations are included in the 2022 annual report. Each association president shared the following highlights from their report.

- **CES/TERSSA** Patty Corfman a new CES logo, brochure and video were created in 2022. The national TERSSA conference was held September 20-23 in Kitty Hawk, NC. There were 19 attendees from Ohio. The TERSSA Award of Excellence was presented to Christina Byrd. The 2023 conference will be held in Ohio.
- ANREP Sabrina Schirtzinger the biennial conference was held May 31 June 3 in Kalamazoo, Michigan. Nine individuals from Ohio attended the conference. The 2024 biennial conference will be May 6-8 in Hershey, PA.

- NACAA Lee Beers annual conference was July 17-22 in West Palm Beach, FL. There were 47 attendees from Ohio. Ohio was well represented in concurrent sessions and awards with five regional award winners and two national award winners. The 2023 conference will be August 13-17 in Des Moines, Iowa.
- NACDEP James Morris annual conference was June 5-8 in Indianapolis, IN. Ohio members received three second place national awards and three regional awards. The 2023 conference will be April 30-May 2 in Coeur D'Alene, Iowa.
- NAE4-HYDP Christy Clary Fifty-nine Ohio members participated in the annual conference October 10-13 in Madison, WI. Nine first-timer \$200 scholarships were given to individuals with under three years of service to help them attend, and funds remain available to continue offering them in the future. Ohio was well represented in both presentations and posters including one session that was unplanned. Ten individuals/teams received regional awards, and one individual and one team won national awards. Two Ohio members served on the national board in 2022: Sally McClaskey served as the chair of conferences and was elected to the role of V.P. of conferences and events for 2023, and Theresa Ferrari served as national liaison to the board for the Journal of Extension and will continue in that role in 2023. The 2023 conference will be in Pittsburgh, PA October 10-12.
- **NEAFCS** Tammy Jones Thirty-nine Ohio members attended the 2022 annual session in Raleigh, North Carolina from September 12-15. Ohio members presented six concurrent sessions, one showcase of excellence and one in-depth session at the conference. Ohio members received one national award and seven regional awards. Two Ohio members served on the national board in 2022: Kate Shumaker was secretary and Pat Brinkman (a life member) was V.P. of professional development. The 2023 annual session will be September 11-14 in Providence, RI.
- NAEPSDP Amanda Rysz annual conference was November 29 December 1 in Ft. Lauderdale, FL. Ohio member Teresa McCoy will end her two-year term as North Central region representative at the end of 2022, just served as president elect, and is currently serving as the national president.

## Committee Reports

Full reports for all committees are included in the 2022 annual report. Each committee chair stated the following highlights for their report.

- Retirees & Life Members Ron Overmyer no report
- Global Relations Godwin Apaliyah no report
- Marketing Cheryl Buck In 2022 the committee continued their efforts to educate members through social media, websites, videos, and Microsoft Teams. Website updates were made, moving JCEP information to the operations portion of the main Extension page. After reviewing and discussing the possible editing of a video developed in 2019, the decision was made to film new footage at annual conference. Danielle Combs will serve as committee chair in 2023.
- Membership Recruitment and Retention Mark Badertscher –The 2022 membership drive (in October 2021) garnered 390 full members and 45 affiliate members. To clarify membership options in advance of the 2023 membership drive, a document was updated to make it more inclusive and usable from year-to-year. Initial membership recruitment invitations for 2023 were sent by email on October 5, and committee members reached out personally to all new Extension professionals to

- encourage them to join JCEP and their professional associations. Curtis Young will serve as committee chair in 2023.
- **Personnel** Chris Zoller In collaboration with Jackie Wilkins, Director of OSU Extension and Jeff McCutcheon, Director of Operations for OSU Extension, a salary study was initiated in 2022. The study consisted of two phases: phase 1 was internal, and results will be announced during annual conference; phase 2 will be a comparison with similar institutions. In 2023, the committee plans to evaluate the salary study results and recommend actions, as well as focus on employee retention efforts. Chris will continue to serve as committee chair in 2023 with Sandy Trushel as a co-chair.
- **Policy** Dan Lima In 2022 the policy committee reviewed the by-laws of Ohio JCEP and suggested changes. During the October 17 board meeting the board voted to accept the proposed changes, including the addition of a statement allowing members to petition the board to join mid-year if they miss the membership drive while on leave (medical, parental, military, etc.). Jessica Adams will serve as committee chair in 2023.
- **Professional Development** Christy Millhouse In 2022, the committee continued to offer virtual "hallway conversations" to provide an opportunity for colleagues to connect with one another. With the return of in-person meetings, the committee decided to discontinue these events. In 2023 the committee plans to meet with the OSU Extension Learning and Organizational Development team to discuss how to best work together to provide opportunities for Extension employees. Christy will continue to serve as committee chair in 2023.
- Public Issues Kathy Bruynis the public issues committee at the national level
  was sunset at the 2022 ESP conference, but the Ohio committee will continue to
  meet at least through 2023. An elevator video speech contest is planned for 2023 to
  discuss what Extension is and how to work with elected officials. Kristy Watters
  will serve as chair in 2023.
- Resource Development and Management Nate Arnett The committee met around each JCEP Board meeting and conducted spot audits at face-to-face board meetings. Primary activity in 2022 included supporting the treasurer in developing and using an updated tracking and reporting process and learning to better utilize WorkDay and university funds to support JCEP efforts. The committee again recommended half price membership dues for 2023 due to healthy balances and lower expenditures than budgeted in 2022. A full fiscal review and audit was completed on October 31. The checking account was found to be accurate and well notated for expenses and income. Funds held with OSU were tracked and reconciled appropriately with two notations: (1) an expense to the general fund was mistakenly charged and has since been addressed, and (2) Central State University (CSU) was not billed for memberships in 2022 (\$4,620). The treasurer will create an invoice and request those funds from CSU. Melinda Ryan will serve as committee chair in 2023.
- Scholarships, Grants and Recognition Amanda Raines the committee coordinated award selection processes in 2022 for creative works, team teaching, special chapter (including Friend of Extension) and Excellence in Extension awards. The committee worked with CES officers to update their service awards, so they are now parallel to the ESP service awards, and they updated award certificates to be inclusive of CSU. The committee worked closely with the annual conference planning committee to

ensure all aspects of the award presentation went smoothly. The professional development subcommittee was able to award all scholarship funds in 2022 through 15 professional development awards, but the grants subcommittee only awarded one grant as there was only one application. The issue of too many different deadlines and emails was discussed, and it was decided the professional development and grants subcommittees would work in tandem in 2023, aligning their application deadlines and announcements for both opportunities to reduce confusion. Jessica Rocky will serve as committee chair in 2023.

Ohio had 369 members in 2023.

Re-cap on National ESP Conference in Billings, MT: Sept 24-28, 2023

- 36 attendees (including 1 from Central State) & 7 guests (one of the largest delegations from Ohio ever)

## 2. Summary of GRC Minutes Outcomes

## Domestic Multicultural Engagement Initiative:

For instance, American Farm School is bringing students to Ohio in Warren County next year.

Our group met six times throughout the year.

- The goal this year was to make sure that Constitution and By-laws was inclusive with Central State and Ohio State.
- In February we reviewed the OJCEP Mission Statement after it was brought to the committee's attention Central State was included.
  - O Policy Committee proposed changes to the board on wording to include Central State in the mission statement to read, "To promote the professional development of and to provide ongoing support for the professionals of Ohio Land Grant Universities."
- The changes to the Committee descriptions were:
  - Constitution
    - Article I: The name of the organization shall be the Ohio JCEP (OJCEP hereafter). OJCEP shall be the Alpha Eta chapter of Epsilon Sigma Phi (ESP) and serve as the Ohio Joint Council of Extension Professionals.
    - 2. Article III, Section 3: Ohio JCEP is guided by the Non-Discrimination policies of the Land Grand Universities, Central State University and The Ohio State University.
    - 3. Article VII, Section 1: Upon termination or dissolution of the OJCEP, any assets lawfully available for distribution shall be distributed to one (1) or more qualifying organizations described in Section 501(c)(3) of the Internal Revenue Code of 1986 (or described in any corresponding provision of any successor statute) which organization or organizations have a charitable purpose which, at least generally, includes a purpose similar to the terminating or dissolving organization.

Any assets not so disposed shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is located. Disposal shall be made exclusively for exempt or public purposes or be made to such organization or organizations as the court shall determine to be organized exclusively for such purposes.

- All changes were approved by the committee during our October 2023 meeting and submitted to the OJCEP board for review more than 30 days in advance of the next board meeting.
- If board approves proposed changes in December, the new constitution and bylaws will be stamped "2023" and will be followed in 2024.

#### Ohio Joint Council of Extension Professionals Constitution

#### ARTICLE I - NAME

The name of the organization shall be the Ohio Joint Council of Extension Professionals (OJCEP). OJCEP shall be the Alpha Eta chapter of Epsilon Sigma Phi (ESP).

## ARTICLE II - PURPOSE

The mission of the organization shall be to promote professional development and support professionals within Extension in Ohio.

#### ARTICLE III - MEMBERSHIP

Section 1: Membership shall be Annual or Life member.

- A. Annual membership: Any Ohio Extension employee who is current with their dues may be an annual member of this association.
- B. Life membership: Those members who have retired and have paid lifetime dues. Life membership to this association shall carry with it the right to attend all meetings and take part in all discussion.

Section 2: Voting. Voting privileges shall be extended to all Annual and Life members.

Section 3: The Ohio State University is committed to building and maintaining a diverse community to reflect human diversity and improve opportunities for all. #### ARTICLE V - MEETINGS

- Section 1: A minimum of one annual meeting of the membership shall be held.
- Section 2: Executive, Board and Special Meetings of the organization shall be held as specified in the By-Laws.

#### ARTICLE VI - AMENDMENTS

- Section 1: The Constitution shall be amended, revised, or repealed by twothirds vote of the members of the organization participating in the membership meeting (electronic voting and teleconference meetings allowed).
- Section 2: The amendments or revisions of the Constitution shall take effect as soon as adopted.
- Section 3: The Constitution may be amended provided written notice stating the substance of the proposed amendments has been sent to each member at least fifteen days in advance of the membership meeting.

## Ohio Joint Council of Extension Professionals By-Laws

#### ARTICLE I - NAME AND PRINCIPAL OFFICE

- Section 1: The name of the organization shall be the Ohio Joint Council of Extension Professionals (OJCEP).
- Section 2: The principal office of the organization will be housed at the office of the current organization Treasurer.

#### ARTICLE II - MEMBERSHIP

- Section 1: Membership in the organization shall be from January 1 to December 31.
- Section 2: The membership dues deadline is October 31 and the dues are for the period January 1 to December 31 of the following year.
  - In the event the deadline is missed due to a leave of absence, the board can approve membership outside the stated deadlines for Ohio JCEP membership on an individual basis.
- Section 3: Change in rate of annual dues must be approved by the majority of the Board.
- Section 4: Annual membership has two levels with benefits and limitations as described below:
  - Full member Full access to Ohio JCEP offices and benefits.
  - Affiliate member Limited to support staff only, access to affiliate-only Ohio JCEP scholarships/professional development support, may hold Ohio JCEP office to represent CES only, restricted awards eligibility, may fully participate in Ohio JCEP committees but not hold Chair/Chair- elect roles.
- Section 5: To be eligible for awards or to run for elected office (as consistent with membership level), members must have paid their membership dues by October 31 for the current membership year.
- Section 6: Those newly employed will be exempt from the previous year membership requirement.
- Section 7: Members must complete their membership form on-line and submit it electronically to the organization Treasurer.

#### ARTICLE III - BOARD OF DIRECTORS

Section 1: Board of Directors shall consist of:

- President
- President-Elect
- Past President
- Annalist
- Secretary
- Treasurer
- State Association Presidents: Eight (8):
  - o Association of Natural Resources Extension Professionals (ANREP)
  - Epsilon Sigma Phi (ESP)
  - National Association of County Agriculture Agents (NACAA)
  - National Association of Community Development Extension Professionals (NACDEP)
  - National Association of Extension 4-H Youth Development Professionals (NAE4-HYDP)
  - National Extension Association for Family and Consumer Sciences (NEAFCS)
  - National Association of Extension Program & Staff Development Professionals (NAEPSPD)
  - Chi Epsilon Sigma/The Extension and Research Support Staff Association (CES or TERSSA)
- State Association President-Elects: Eight (8): Refer to organizations listed above.
- Committee Chairs: Nine (9)
   (Global Relations; Marketing; Membership Recruitment and Retention;
   Personnel; Professional Development; Public Issues; Resource
   Development and Management; Scholarships, Grants and Recognition,
   and Policy)
- Retiree/Life Member

## Section 2: Terms on the Board of Directors shall be as follows:

- A. The President-Elect is elected annually. President-Elect is a three-year commitment and shall become President the year following the President- Elect term and become Immediate Past-President following the term as President.
- B. The Secretary and Treasurer are two-year terms and shall serve no more than two consecutive terms. The Secretary and Treasurer terms will be elected on alternate years.
- C. The Treasurer-Elect shall be elected the last year of the current Treasurer's term and serve no more than one year. In the event the current Treasurer does not fulfill their term, the Treasurer-Elect will assume the position of Treasurer.
- D. The Annalist shall be elected to a two-year term and serve no more than two consecutive terms.

- E. State Association President-Elect is a two-year commitment. State Association President-Elect officers are elected annually and shall become the State Association President the following year.
- F. Committee Chairs will be selected by membership of the committee and are voting members of the Board. There is a limit of two 1-year terms in a Committee Chair position.
- G. Retiree/Life Member Representative is a one-year term from active life members appointed to Board.
- Section 3: A member shall hold only one Board voting position at any one time.
- Section 4: Vacancies shall be filled in the following manner:
  - A. Any position-elect shall assume the related position if those offices become vacant during the year. The Board shall appoint an appropriate representative to fill the remainder of the vacant position of any elected officer.
  - B. In the case of non-elected positions, the Board will seek nominations from that organization or committee to fill the term of the vacant position.

## ARTICLE IV - MEETINGS

- Section 1: Annual meetings shall be held as determined by the Board of Directors.
- Section 2: Regular meetings shall be called as deemed necessary by the President and/or the Board of Directors.
- Section 3: Special meetings shall be called as deemed necessary by the President and/or five members of the Board of Directors.
- Section 4: Quorum of the Board of Directors shall consist of half the membership plus one. Section 5: Parliamentary Procedure shall (except as herein provided) be conducted according to Roberts Rules of Order, Modern Edition.
- Section 6: Each Board member shall have on vote and the President shall cast the deciding vote in the case of a tie.
- Section 7: Members of the Board of Directors may be dismissed for missing two consecutive meetings unless excused.

#### ARTICLE V - BOARD OF DIRECTOR DUTIES

- Section 1: The election of Board members shall be held annually as determined by the Executive Committee. The term of office shall coincide with the membership year as stated in Article II, Section 1 of the By-Laws.
- Section 2: The President shall perform such duties as pertain to this office: prepare agendas and preside at the annual meeting and all Board meetings, represent, or appoint other members to represent OJCEP on committees or functions and keep lines of communication open among the OJCEP Board, national ESP, and the administration of Ohio land grant universities.
- Section 3: The President-Elect shall make all arrangements for the annual meeting, assemble, and distribute the OJCEP annual reports to members, channel suggestions from members to the attention of the officers and Board, preside over meetings in absence of the President.
- Section 4: The Past President shall work closely with the President, serve as chair of the Nominating committee, and conduct elections as determined by the Executive Committee.
- Section 5: The Secretary shall keep full and accurate records of proceedings and attendance of all meetings of the OJCEP, receive and keep properly filed communications, attend to correspondence as directed by the President, and prepare official stationery.
- Section 6: The Treasurer shall keep a full and accurate record of all receipts and disbursements of OJCEP. The Treasurer shall pay bills and accounts for OJCEP as directed by the President and Executive Committee, OJCEP Board, or by resolution passed by the membership. The Treasurer shall prepare financial statements for meetings, collect all membership dues, make deposits on a regular basis, record national association affiliation, provide appropriate information to the Membership Chair, work with State Association Presidents in submitting the dues for each National Association, and give leadership to the Resource Development Management Committee.
- Section 7: The Treasurer-Elect will be a non-voting Board member. This officer will serve as an apprentice to the current Treasurer for one year but will not have check signing authority.
- Section 8: The Annalist will maintain the historical records of OJCEP and the ESP Alpha Eta Chapter.

- Section 9: The State Association Presidents shall be a liaison and contact person with respective national associations and persons in other states with similar positions; represent OJCEP members who are members of respective national associations at annual and regional meetings of the respective national associations; appoint delegates and provide leadership for the Ohio delegation to national and other committees as necessary; coordinate and relay information concerning selection of respective national association award recipients to Scholarships, Grants and Recognition Committee; coordinate membership efforts with directors concerning membership in OJCEP and respective national associations; take responsibility for disseminating information concerning registration, travel arrangements, national elections, special meetings and other details of respective national association annual meetings; strive to promote fellowship among members at regional and state workshops and conference, etc.; keep the Board informed and involved concerning decision, plans, and activities related to this position. The Association President will be encouraged to attend the Extension Leadership Conference with OJCEP covering expenses as determined by the Board of Directors.
- Section 10: The Association President-Elects shall assist the Association Presidents as requested and record proceedings of sectional meetings. The Association President-Elect will be encouraged to attend the Public Issues Leadership Development (PILD) Conference with OJCEP covering expenses as determined by the Board of Directors.
- Section 11: The Retiree/Life Member shall function as the liaison with Extension retirees and encourage life membership with recent retirees. Work with the Treasurer to update the national ESP life membership list.

#### ARTICLE VI - COMMITTEES

- Section 1: Standing committees shall be determined by the Board of Directors.
- Section 2: Committee Chair and Vice-Chair will be selected by the members of the committee present when vote is taken, no later than October 31 before their term commences.
- Section 3: Executive Committee: The executive committee shall be comprised of the five officers and the State Association Presidents. The purpose of this committee shall be to compose an agenda for all Board of Director meetings and determine election procedures for Board of Directors of the organization.

- Section 4: Personnel Committee: This committee shall monitor and report on salary and benefits information; monitor and access the advantages and disadvantages of the faculty promotion and tenure process or the advancement system of unclassified administrative and professional (A&P) and/or senior administrative and professional employees and conduct or obtain access to a salary analysis comparing North Central Regional States for faculty and nonfaculty. Members of Extension administration are not permitted to serve on this committee.
- Section 5: Global Relations Committee: This committee promotes international opportunities and international programming within Extension. Liaison and connect with national ESP committee efforts.
- Section 6: Marketing Committee: This committee publishes communications used by members; oversees web development as well as additional technology-based member communications; works closely and clarifies roles with Membership Recruitment and Retention Committee. Liaison and connect with national ESP committee efforts.
- Section 7: Membership Recruitment and Retention Committee: This committee recruits, retains and involves all eligible Ohio Extension personnel; promotes an effective working relationship and spirit of fraternal fellowship among members. Initiates and coordinates annual membership process. Liaison and connect with national ESP committee efforts.
- Section 8: Professional Development Committee: This committee shall support, promote, and develop professional opportunities for Extension employees. Liaison and connect with national ESP committee efforts.
- Section 9: Public Issues Committee: This committee builds and strengthens political and public support for Extension through consistent and targeted communication with local, state, and federal decision makers and agencies; and educates and informs members about public issues and legislative matters affecting Extension programs and staff. Liaison and connect with national ESP committee efforts.
- Section 10:Resource Development and Management Committee: This committee generates new ideas for resource development and management for professional development activities; reviews and monitors the professional association's financial management plan. Liaison and connect with national ESP committee efforts.

- Section 11:Scholarships, Grants and Recognition Committee: This committee administers and provides leadership to the state, regional and national award programs and oversees the selection and distribution of professional development scholarships. Liaison and connect with national ESP committee efforts.
- Section 12:Policy Committee: This committee has the goal of ensuring the Board has policies and procedures in place to guide the operation of the Organization and adheres to these policies. Reviews the Constitution and By-laws annually and submits proposed changes to the Board.
- Section 13:Ad Hoc Committee: An Ad Hoc Committee may be appointed by the President. No Ad Hoc Committee shall serve longer than twelve months unless re-appointed.

#### ARTICLE VII - FISCAL MATTERS

- Section 1: The OJCEP fiscal year is October 1 to September 30.
- Section 2: The funds of OJCEP shall be deposited in institutions as determined by the Board of Directors Executive Committee. The authorized signatories include the OJCEP Treasurer and the Past OJCEP Treasurer or OJCEP member recommended by the Treasurer and approved by OJCEP Board.
- Section 3: There shall be an annual audit of the financial affairs of OJCEP as determined by the Board of Directors Executive Committee. A report of the general financial condition shall be made annually to all members.
- Section 4: State Association Presidents shall provide approval and direction to the OJCEP Treasurer and Membership Chair as well as provide a contact address and deadline for national dues for fiscal matters specific to their respective state association.

#### ARTICLE VIII - AMENDMENTS

- Section 1: The By-Laws may be amended at any regular or special meeting (including electronic meeting/voting) of the Board of Directors by a majority vote of the Board members, provided that written notice stating the substance of the proposed amendment has been sent to each Board member at least ten days in advance of the vote.
- Section 2: The amendments or revisions of the By-Laws shall take effect as soon as adopted.
